Regular Board Meeting
August 14, 2008

The regular meeting of the Wickes School Board was called to order by President Rodney Saddler at 7:00.

Roll Call: Linda Gillaspy, Rodney Saddler, Barry Bailey, Scotty Polk, Jerry Watkins, Jeff Cook. Absent: Doug Curtis.

Board retired into executive session at 7:01. The board reconvened at 7:05.

Motion was made by Linda Gillaspy and 2nd by Barry Bailey to approve the minutes of the previous meeting. Vote: unanimous.

Motion was made by Linda Gillaspy and 2nd by Barry Bailey to approve the previous financial reports. Vote: unanimous.

Motion was made by Scotty Polk and 2nd by Jerry Watkins to approve the legal transfer for Deianeira and Briar Oliver from Van-Cove to Wickes. Vote: unanimous.

Motion was made by Scotty Polk and 2nd by Jerry Watkins to approve the following student Freedom of Choice application:
Jade Marie Blough from Nashville to Umpire.

Motion was made by Jerry Watkins and 2nd by Scotty Polk to accept the playground bid for Gametime at \$30,591. Other bids submitted were Noah's- \$29,000, Playcraft- \$29,648. The Gametime bid is recommended because it will include more equipment. The Wickes Elementary raised approximately \$10,000. The district will match and then use the remainder of building fund for the WES to purchase. Vote: Unanimous

Mr. Blackwell discussed that he would be checking into purchasing a trip bus for Umpire and that we would use the Isolated Transportation money for it.
