Regular Board Meeting
February 12, 2008

The regular meeting of the Wickes School Board was called to order by President Rodney Saddler at 6:05 p.m.

The board retired into executive session at 6:06 pm.
They board reconvened at 6:30 pm.

Motion was made by Linda Gillaspy and 2nd by Jeff Cook to approve the minutes of previous meeting. Vote: unanimous.

Motion was made by Doug Curtis and 2nd by Barry Bailey to approve the financial reports. Vote: unanimous.

Motion was made by Jerry Watkins and 2nd by Doug Curtis to allow the transfer of Summer and Brycelynn Raines from Wickes to Cove. Vote: unanimous.

Motion was made by Jerry Watkins and 2nd by Jeff Cook to deny the transfer of Kyle Deer from Umpire to Dierks. Vote: unanimous.

Motion was made by Jerry Watkins and 2nd by Linda Gillaspy that Wickes Elementary hold after school tutoring for 1 hr per day with 5 teachers, 4 days a week for a total of 11 weeks, and the Wickes High School hold after school tutoring 2 days per week for 10 weeks with 2 teachers. With salary and benefits the total would be approximately \$6900 to be paid with NSLA funds. Vote: unanimous.

Motion was made by Doug Curtis and 2nd by Jeff Cook to renew the contracts of WES principal Megan Witonski, WHS principal Andrew Curry, UES/UHS principal Dewayne Taylor with a \$1250 raise, and to renew Federal Coordinator Patsy Stewart's contract as is. Vote: unanimous.

Motion was made by Jerry Watkins and 2nd by Jeff Cook to reconvene.

Motion was made by Doug Curtis and 2nd by Barry Bailey to accept the classified policy concerning the paying of accumulated sick leave when their employment with the district has ended. The rate of pay will be at the rate of a non-certified substitute teacher, and the contracted classified employee must have worked for the Wickes School District a minimum of 5 years. Vote: unanimous.
